- a) To consider <u>hiring a public officer, employee, staff member or individual agent.</u> (does not apply to filling a vacancy in an elective office or deliberations about staffing needs in general)
- **b**) To consider the <u>evaluation</u>, <u>dismissal</u>, <u>or disciplining of</u>, <u>or to hear complaints</u> or charges brought against a public officer, employee, staff member, or individual agent.
- c) To acquire an interest in real property which is not owned by a public agency.
- d) To consider records that are exempt from disclosure as provided in chapter 1, title 74 Idaho Code.
- e) To consider <u>preliminary negotiations involving matters of trade or commerce</u> in which the governing body is in competition with governing bodies in other states or nations.
